Pursuant to notice duly posted on September 8, 2017, a SPECIAL meeting of the Port O'Connor Improvement District was called to order on Tuesday, September 12, 2017 at 1:00 p.m. in the District's office located at 39 Denman Drive, Port O'Connor, Texas

### A. CALL TO ORDER

President Leon Brown called the meeting to order and established that a quorum was present and welcomed everyone.

B. ITEMS FOR CONSIDERATION AND TAKE APPROPRIATE ACTION IF NEEDED: \*

1. "Presentation of information for upcoming 2017/2018 budget by Kaye Townley of Municipal Accounts."

Kaye Townley gave the presentation for the 2017/2018 budget. President Brown would like subcategories under miscellaneous category so they know what they are for with a GL code. President Brown requests that code 14300 be taken down to \$5,000 and for code 14330 to stay at \$10,000. The Board requested that USW Utility Group find out if they are to pay for Fagan answering Service or if it is the districts cost. The board requested the Election expense be made to a \$0 amount as there will be no election till the following year. Director Brown presents his issues with USW Utility Groups base contracts price, he would like maintenance tech removed. The board went into recess at 2:10 p.m. and restarted at 2:16 p.m., Kaye Townley redid the base rate for USW Utility Group at \$879,244.35. President Brown would like Administrative fees to be more specific and have subcategories. Upgrades for assets will be paid through bond. The board went in a recess at 2:44 p.m. and went back in session at 2:52 p.m.

2. "Review proposal of Mark Barnes, land asset report for Port O Connor Improvement District and authorize the President to execute a professional services agreement with Mark Barnes after review by General Counsel."

Mark Barnes will do an appraisal on districts eleven lots for \$3,400, Director Bradford was allotted \$1,500, but was not recorded in the minutes.

Director Bradford makes a motion to approve Mark Barnes proposal.

3. "Review proposals for front door lock and authorize the President to execute a purchase order with the board approved proposal."
